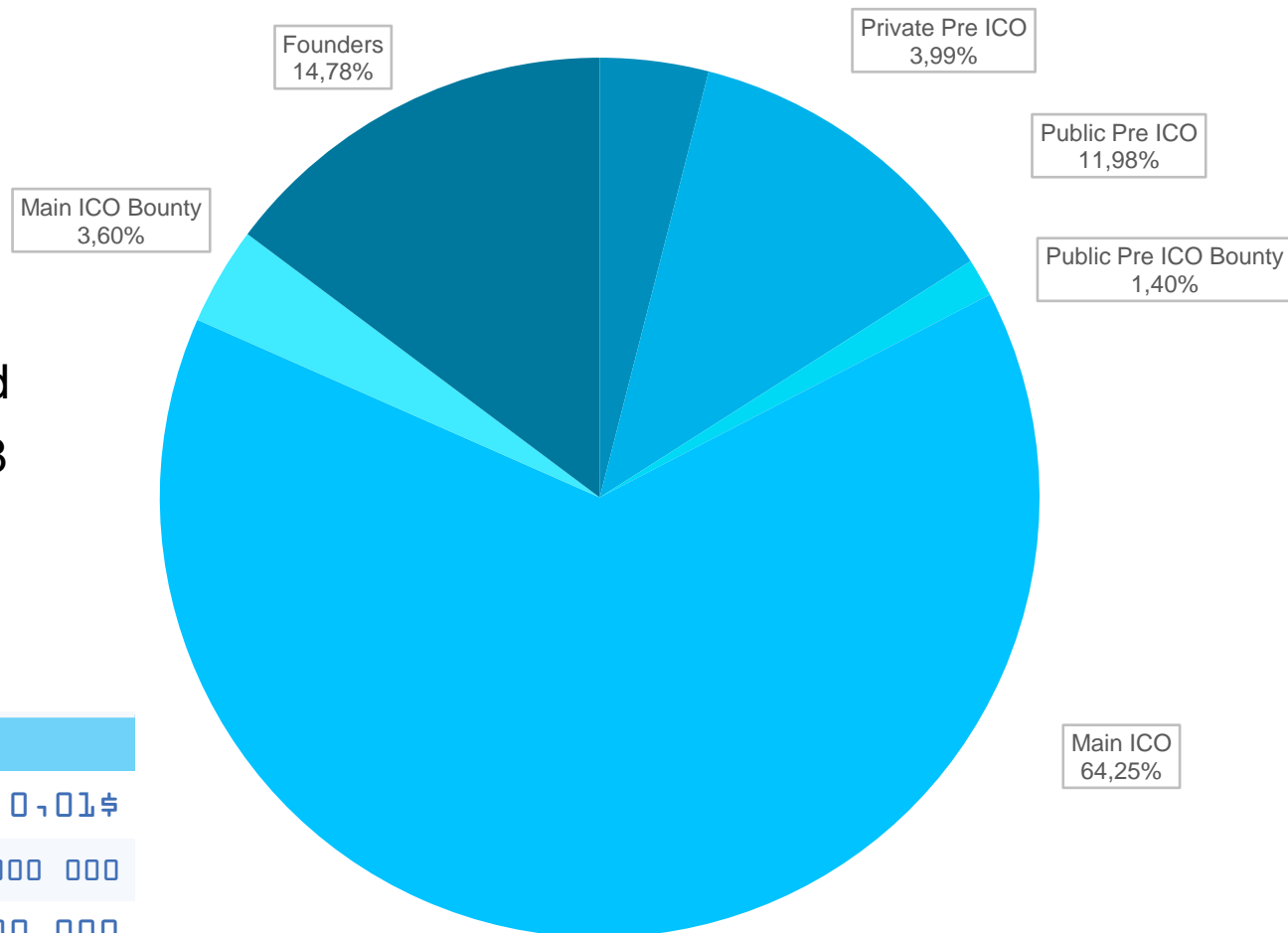

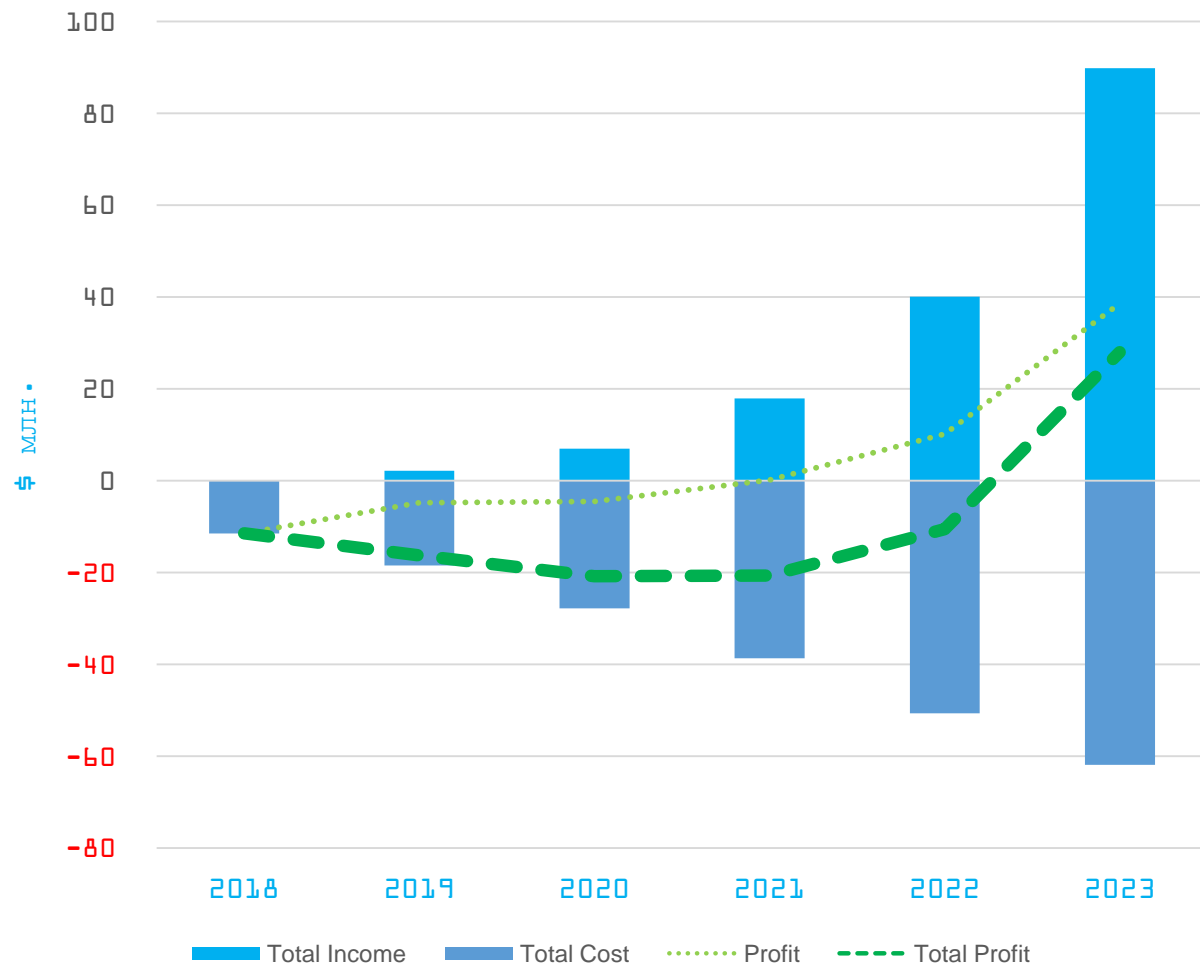

Corporate accounts have been opened in the biggest cryptocurrencies exchanges

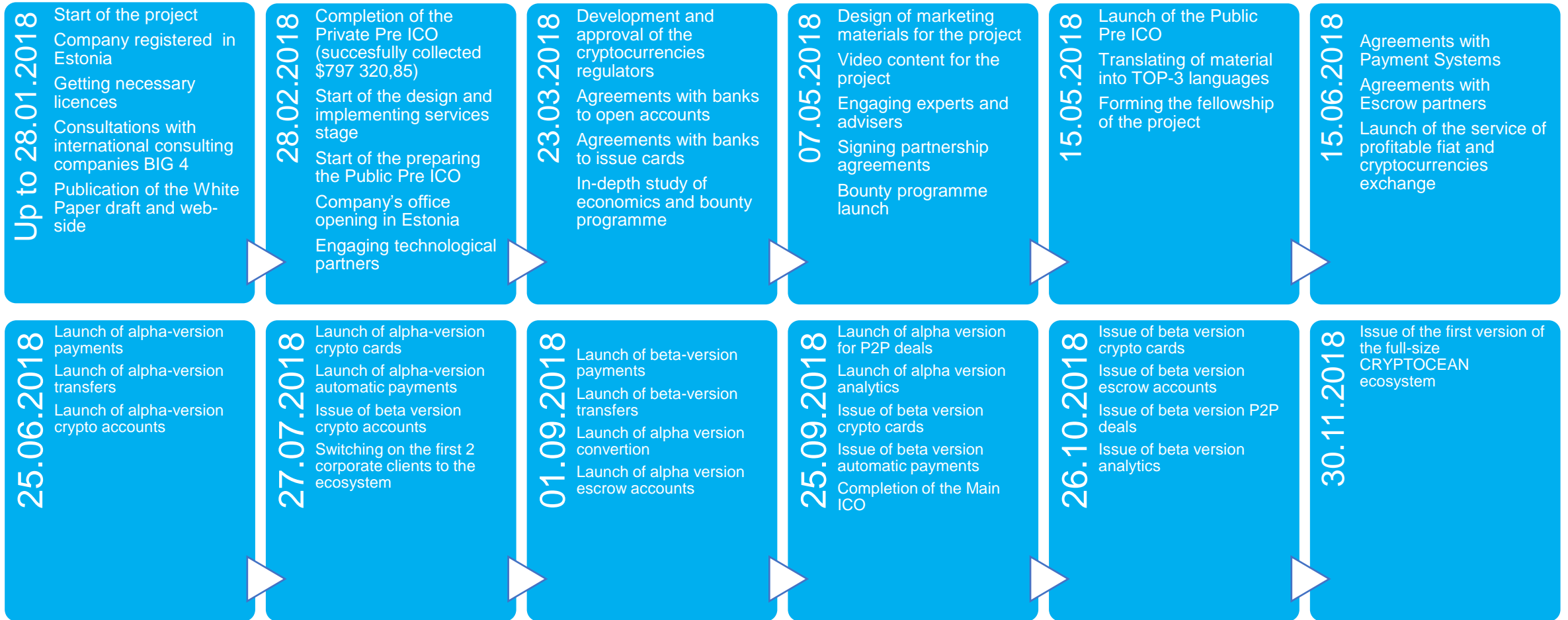
Agreements with EU banks have been made regarding release of plastic cryptocards

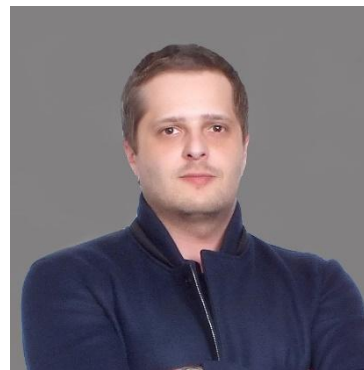
